SUPERINTENDENT'S PRESENTATIONS

Grades 3-8 Assessment Overview

Dr. Talbert gave an overview of the 2020-2021 Grades 3-8 Assessment. She shared with the community that New York State submitted to the US Department of Education for a waiver for students not being required to test during the height of the pandemic. Test refusals for 2021 will not be used to penalized districts and students who received entirely remote instruction during the 2020-2021 school year was exempt. Mrs. Simpson and Dr. Jordan shared the statistical data for those who did test.

This was followed up with several questions from trustees regarding the participation rate and opt-out procedures.

## **Straight Path Construction**

Dr. Talbert, along with Mr. Snyder, shared an update regarding the construction on Straight Path in relation to the sewer connection project. Mr. Snyder stated that construction started a few days ago and began digging along Straight Path to connect to the Suffolk County sewer line. They are starting to work around the district's administration building, to connect with LaFrancis-Hardiman and Martin Luther King Jr. Elementary schools and then work near the bus garage and also through the access road so the connections can be made. Estimated timeframe for completion is in January 2022.

Trustees voiced concerns about traffic patterns and safety. A question was also asked about the scheduled construction being on time.
