WHEREAS, Tetra Tech Architects & Engineers, Savin Engineers and the School District's Administration reviewed the bids submitted in response to the Invitation to Bid; and

WHEREAS, based upon such review, in the best interests of the School District, the School District Administration recommends that, the Board of Education award to the Hirsch & Co. LLC, the lowest responsible bidder;

NOW THEREFORE BE IT RESOLVED, that the Board of Education of the Wyandanch Union Free School District awards the bid for Tetra Tech Project No. 08502-21001 – Reconstruction to Martin Luther King Jr. Elementary School and LaFrancis Hardiman Elementary School/District Administration Office & Bus Garage (SED Project Nos. 58-01-09-02-0-002-030 & 58-01-09-02-5-007-010) to the below contractor at a total cost of Eight Hundred Ninety Three Thousand Dollars (\$893,000):
