 <u>Positions</u>

The projected operating surplus for the 2022-23 year is currently \$2,700,000

Factors that led to an improved fiscal score:

- Improved fiscal position ratio
- Elimination of operating deficits
- Return to operating surpluses



2023-24 Preliminary Budget



2023-24 Budget Highlights

- The 2023-24 draft budget is currently set at \$107,239,846
- The 2023-24 draft budget includes \$7,493,987 in new programs and restored services.
- The estimated tax levy cap calculation permits the district to raise the levy by 1.34%.
- State Aid Funding:
 - For 2022-23, state aid is funding 71.1% of the 2022-23 budget
 - For 2023-24, state aid is projected to fund 80.4% of the draft budget

Why do the figures used by the District differ from the Governor's proposal?

- ❖ State aid proposals are estimates. Current year figures tend to get overstated and base year figures tend to be understated

Capital Reserve





Capital Reserve (Ed Law 3651)

- A Capital Reserve Account may be established to pay for construction costs that would ordinarily require bonds to be issued.
- Creating a Capital Reserve requires voter approval
 - Resolution language includes the purpose of the capital reserve, ultimate dollar amount, probable term and source of funding.
- Spending money from the reserve requires additional voter approval and the expenditure must be for a specific purpose.



Wyandanch UFSD Capital Reserve

- Recommendation is to establish a capital reserve with a separate proposition on May 16
- Proposition language to include:
 - Purpose Scope TBD
 - Amount recommendation is \$15,000,000
 - <u>Term</u> TBD
 - Source of Funding budgetary surpluses, budgetary appropriations and transfers from other reserves as permissible by law
- The 2023-24 Budget already includes a 4,228,871 appropriation to fund our capital reserve.
