Stephanie Howard, District Clerk, arrived at 6:05 AM. Rutha Bush, Chairperson, arrived at 6:00 AM and Juanita Jones, Chief Inspector, arrived at 6:25 AM. Robert Scotti, the custodian from Suffolk County Board of Elections, arrived at 6:15 AM. Poll Inspectors Patti Bullard, Florence Collins, Virginia Dawson-Taylor, Martin Jackson, Juanita Jones, Carrie King, Edna Perkins, Deborah Richberg, Leah Richberg, Eileen Watson, and Stephanie Williams were all present by 6:00 AM. Lisa Hutchinson, Esq., General Counsel, arrived at 6:25 AM.

At 6:24 AM, Mr. Scotti unlocked and opened Voting Machine #2 (#T1034), and then unlocked and opened Voting Machine #1 (#B282) at 6:34 AM as observed by Chairperson and Poll Inspector. The Certification Tape verified that all candidate vote totals were at zero. The custodian verified, with all observing, that the baskets within the voting machines were empty, and the voting machines were sealed. The Protective counter for Voting Machine #1 was 1912 and for Voting Machine #2 was 4947.

The District Clerk administered the Oath of Office to the Chairperson, Chief Inspector and Poll Inspectors at 6:55 AM. The polls were declared open by Chairperson Bush at 7:00 AM sharp.

Voting continued throughout the day without further major incident. It is noted that Voting Machine #2 experienced some paper jamming several times during the day, but after instructions were followed, ballots were able to be cast.

Rutha Bush, Chairperson, declared the polls closed at 9:00 PM. There were two people remaining to vote.

At 9:05 PM the doors were opened for the candidates and poll watchers. Voting results from Machine #2 were announced by Chairperson Bush at 9:07 PM. Voting results from Machine #1 were announced by Chairperson, at 9:10 PM. Absentee ballots were opened, read and counted by the Chief Inspector and Poll Inspector at 9:10 PM, with the District Clerk and the Attorney confirming the tabulation. Chief Inspector and Poll Inspector also checked the list of names of those who voted by absentee ballots against the poll list to ensure that no one had voted twice. Ballot boxes were emptied by the custodian and observed by the Chairperson, Chief Inspector, Attorney and District Clerk. Ballots, closing voting machine tapes and memory cards were turned over to the District Clerk by the custodian.

At 9:30 p.m., the Chairperson with District Clerk declared the following results:
