AUTHORIZATION FOR RENEWAL OF SERVICES AGREEMENT: THE OMNI GROUP, 2023/2024

BACKGROUND INFORMATION:

Families of the Wyandanch School district employees are being asked to take greater responsibility for their retirement income replacement needs. Public school teachers and other school employees are increasingly relying on their personal 403(b) and 457(b) plans for financial support during retirement, a trend which is expected to accelerate in the coming years.

District officials play a key role in the proper administration of these plans and the determination of the companies that are available to their plan participants. Complex regulatory requirements must be met, and hundreds of investment companies are available to even the smallest school district. As such, district officials must know that the investment companies and the investment vehicles offered under these supplemental plans will assist in the proper administration of these plans and meet a high standard of quality, as well as complying with the new Federal laws and statutes covering these plans.

The Omni Group has established a set of standards, through their Preferred Provider Program that must be met by providers offering 403b and 457b investment vehicles and determine which providers are willing to assist districts in the payment of plan administrative costs. The P3 Initiative seeks to ensure better quality retirement plans for public school district officials and their employees.

Companies selected through the Request for Information (RFI) process will be eligible for Omni's Preferred Provider Program. The program will continue to be offered to Omni's New York State clients, initiated July 1, 2012, and will provide a listing of investment companies that meets certain standards as established by an independent committee of school district officials. ADDENDUM

BOARD OF EDUCATION #6 BoardDocs Ref: 11-A-6

WYANDANCH UNION FREE SCHOOL DISTRICT TO BE ADOPTED ON JUNE 21, 2023

WHEREAS, Part 123 of the Regulations of the Commissioner of Education relating to prohibition the use of indigenous names, mascots and logos by public schools was recently adopted and became effective as a permanent rule on May 3, 2023; and

WHEREAS, Part 123.3 requires boards of education to commit, via resolution, to eliminating the use of prohibited Indigenous names, mascots, and logos by the end of the 2022-2023 school year;

WHEREAS, such resolution must identify a plan to eliminate such prohibited use by no later than the end of the 2024-2025 school year;

WHEREAS, the Board of Education of the Wyandanch Union Free School District wishes to comply with the Regulation by passing this Resolution before the June 30, 2023 deadline; and

WHEREAS, the Board hereby commits to eliminate its present logo by no later than June 30, 2025; and acknowledges that the District has no identifiable mascot; and

WHEREAS, due to the District's history of utilizing stereotypical imagery with its 'Warrior' mascot name the Board hereby commits to not use the word "Warrior" in a manner prohibited by Part 123 by no later than June 30, 2025; and

WHEREAS, the Board has held Community Forums on May 3, May 23 and June 6 to reach out to all stakeholder groups in the District to receive input on the next steps the District should take regarding this matter; and

WHEREAS, the Board reserves its right to Challenge the Regulation pursuant to applicable law and to communicate to, and anticipate working with the New York State Education Department and local politicians to demonstrate that the name "Warrior" should not be prohibited when it is disassociated from indigenous imagery; and

WHEREAS, the Board has formed a Rebranding Steering Committee for input on the implementation of a new image and creation of a logo.

NOW, THEREFORE, BE IT

RESOLVED to the extent required by law, that the attached Plan of Action to (1) disassociate the word "Warrior" from any indigenous group and (2) replace the District's logo in compliance with Part 123 is hereby approved and the Superintendent is hereby authorized to implement same.
